April 6, 2010

The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John Tuttle followed by the Pledge of Allegiance to the Flag of the United States of America. Members present in addition to the Supervisor were Clerk Melanie Curran, Treasurer Linda Sterrett, Trustee Nancy Seydell, and Trustee Mike Haydo. The minutes of all the **March , 2010 Board meetings** as written were approved following a motion by Seydell, seconded by Sterrett. **Vouchers for the fire department** bills were read. Moved to accept the vouchers by Seydell, seconded by Sterrett. Motion carried. **Treasurer's report** was read as: Disbursements of \$11,715.65, deposits of \$30,647.22, and a balance of \$209,170.01.
