August 1, 2006

The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John Tuttle. Members present in addition to the Supervisor were Clerk Melanie Curran, Treasurer Linda Sterrett, Trustee Nancy Seydell, and Trustee Gary Purcell. The minutes of the **July 6, 2006 Regular Meeting Minutes with a correction were approved** following a motion by Sterrett, seconded by Purcell. **Treasurer's report** was read as: Disbursements of \$15,532.71, deposits of \$5,616.30, and a balance of \$124,317.15. The report was approved following a motion by Seydell, seconded by Purcell. **Vouchers for the fire department bills** were read. Moved to accept the vouchers by Seydell, seconded by Sterrett. Motion carried.

Preapprove payment to John Tuttle- \$25.31, Jackson County Resource Facility - \$60.05, and BS&A \$445.00 - Moved by Curran to preapprove payments as stated, seconded by Sterrett. Roll call yes votes: Purcell, Sterrett, Tuttle, Curran, and Seydell. No votes: none. Motion carried.

Public Comment was opened at 7:15 p.m. Comments were received and the meeting continued.

Propane Pre-buy- Moved by Sterrett to approve pre-purchase of 1400 gallons of propane with a rate of \$1.649 per gallon with a total of \$2,308.60. Credit on account is \$594.93, leaving \$1,713.67 balance to pre-buy the propane, seconded by Seydell. Roll call yes votes: Purcell, Sterrett, Tuttle, Curran, and Seydell. No votes: none. Motion carried.

Historical Society Propane- Moved to approve Historical Society to use the township account to purchase up to 500 gallons of propane at the expense of Historical Society to gain the government rate by Tuttle, seconded by Purcell. Motion carried.

Public Comment was opened at 8:13 p.m. Comments were received and the meeting continued.

Eight building permits were read by the Supervisor.

The meeting was adjourned at 8:15 p.m. with nine in attendance.
