January 3, 2006*

The regular meeting of the Tompkins Township Board was called to order at 7:30 p.m. in the township hall by Supervisor John Tuttle. Motion to appoint Coleman J. DeConick as the plumbing inspector for the same fees previously paid to the position by Tuttle, seconded by Seydell. Roll call yes votes: Curran, Seydell, Purcell, Sterrett, and Tuttle. No votes: none. Motion carried.
