**Paint the Stewart Barn** - Moved to contract with Pete Sherlock to paint the barn for \$1650.00 upon a good report from references by Seydell, support Tuttle. Roll call yes votes: all. Motion carried.

**Pre-approve payment of painting the Stewart Barn** - Approve payment upon inspection by Supervisor by Curran, support by Seydell. Roll call yes votes: all. Motion carried.

**MTA - Nuts and Bolts of Township Fire Departments** - Moved to send Curran, Sterrett, and Purcell to the workshop on October 25, 2005 by Seydell, support by Tuttle. Roll call yes votes: all. Motion carried.
