September 4, 2007

The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John Tuttle. Members present in addition to the Supervisor were Clerk Melanie Curran, and Treasurer Linda Sterrett. Trustee Gary Purcell and Trustee Nancy Seydell. The minutes of the **August 2, 2007 Regular Meeting Minutes were approved** following a motion by Seydell, seconded by Purcell. **Treasurer's report** was read as: Disbursements of \$11,782.46, deposits of \$34,701.56, and a balance of \$160,408.93. Moved by Seydell, seconded by Tuttle. Motion carried.
