Special Meeting Minutes
Purpose: Budget 2021- 2022
March 2021

March 15, 2021

The special meeting of the Tompkins Township Board was called to order at 10:00 a.m. in the township hall by Supervisor John A. Tuttle, Sr. Members present in addition to the Supervisor were Clerk Melanie Curran, Treasurer Janine Baldwin, Trustee Nancy Seydell, Trustee Mike Haydo.

The budget was discussed and worked out.

Topics of Discussion: Interest rates have dropped considerably. Parking lot condition, leaf guard on gutters, town hall rental and cleaning, building permits, wages for hourly rate, road projects. All board members at the close of the workshop had no further recommendations for budget considerations.

Public Comment was offered. No comments were received. No one from the public was in attendance. The meeting was adjourned approximately 11:30 a.m.

March 25, 2021

The special meeting of the Tompkins Township Board was called to order at 3:00 p.m. in the township hall by Supervisor John A. Tuttle, Sr. Members present in addition to the Supervisor were Clerk Melanie Curran, Treasurer Janine Baldwin, Trustee Nancy Seydell. Absent: Trustee Mike Haydo. **Minutes** of the February and the addendum for March business was approved following a motion by Seydell, seconded by Baldwin. Motion carried. **Final approval of budget amendments** noted in the previous minutes were approved by Curran, seconded by Baldwin. Roll call votes: all yes. Absent: Haydo. Motion carried. **Previous expenditures approval and treasurer report** was accepted and placed on file by Curran, seconded by Tuttle. Roll call votes: all yes. Absent: Haydo. Motion carried.

Public Comment was offered. No comments and the meeting continued.

Public Hearing was opened for the Hearing of the Proposed Budget 2021–2022 at 3:06 p.m.

The Budget was distributed and discussed by the Board, with one resident present. No questions or comments from the public. The final budget is brought forth for the General Appropriations Act Resolution. Public Hearing was closed at 3:26 p.m. Board meeting resumed.

General Appropriations Act (Budget) 2021-2022 Resolution was read by all. Moved by Tuttle, seconded by Baldwin to adopt the resolution. Roll call votes: all yes. Absent: Haydo. Motion carried. Resolution adopted.

Building Permits - All Building Permit activity permits shall expire one year after purchase, and are available for renewal for 50% of original fee. Moved by Seydell, seconded by Curran. Roll call votes: all yes. Absent: Haydo. Motion carried.

Rental of Town hall – Rental fee for the township hall shall be \$75.00 for residents and \$125.00 for non-residents. Community events pay a \$25.00 fee, except 4-H, TOPS, Historical Society, and Euchre Club, which are expected to clean up after themselves. Moved by Tuttle, seconded by Seydell. Roll call votes: all yes. Absent: Haydo. Motion carried.

Cleaning for Events - \$25 will be paid to the contractor for cleaning the township hall after each paid rental event. Moved by Curran, seconded by Baldwin. Roll call votes: all yes. Absent: Haydo. Motion carried.

Hourly rate compensation for appointed officials, contracted by hour, and election worker shall be \$12.00 effective April 1, 2021. Moved by Tuttle, seconded by Baldwin. Roll call votes: all yes. Absent: Haydo. Motion carried.

Public Comments were invited. The meeting adjourned at 4:35 p.m. with one in attendance.
